If you bring Guests to Clark Rifles they will fill out the **Guest Waiver** and you will endorse it as being responsible for the person you are bringing onto the Range.

The Waiver must be completed and returned to us by **February 15th 2016**. After that date the Membership Card will be invalidated until the Waiver is received. If the Waiver is not received by **November 1st 2016** then that persons Membership will be removed from the Membership Roster. If you are removed from the Roster and want to rejoin you go to the end of the Waiting List.

Yep, I know - - no one wants to receive this information with its over and under tones, I don't either and I don't like writing it, but it doesn't change the fact that this Waiver is necessary to protect Clark Rifles, and you should read it carefully because each of us are giving up significant legal rights when we sign it.

ARTICLE VIII

INDEMNIFICATION

Each Director or officer, or former Director, or former officer, of the Corporation, and his or her heirs, assigns, executors, agents, employees and legal representatives, shall be indemnified by Clark Rifles Inc. against all liability, expense, attorney fees, and related costs and expenses, arising from or out of any action, suit, proceeding, claim, or demand, whether or not suit is actually brought, in which the person shall have been made a party by reason of being, or having been, a Director or officer of Clark Rifles, Inc., provided that Clark Rifles Inc. shall not indemnify any current or former Director or officer with respect to such matters as to which the person shall be finally adjudged in any action,

suit, or proceeding, to have been grossly negligent or engaged in intentional misconduct in the performance of his duties as Director or officer. The indemnification herein set out shall apply also in respect to any amount paid in compromise of any such action, suit, proceeding, claim, or demand asserted against such Director or officer, including expenses, attorney fees, and related costs reasonably incurred in connection therewith, provided that the Board of Directors shall have first approved such proposed compromise settlement and shall have determined that the officer or Director involved was not grossly negligent or engaged in intentional misconduct. In taking such action, any

Director involved and subject to a determination of qualification for indemnification shall not be qualified to vote thereon; and if, for this reason, a quorum of the Board of Directors cannot be obtained to vote on such matter, it shall be determined by a committee of three persons appointed by the Board of Directors. This committee shall include any Director or Directors who are not disqualified, and such additional members as may be necessary to form a committee of three, at a duly called special

meeting, or at a regular meeting. In determining whether or not a Director or officer was grossly negligent or engaged in intentional misconduct in relation to any such matter, the Board of Directors or committee, as the case may be, may rely conclusively upon the opinion of independent legal counsel selected by such Board or committee. The right to indemnification herein provided shall not be exclusive of any other rights to which such Director or officer may be lawfully entitled.

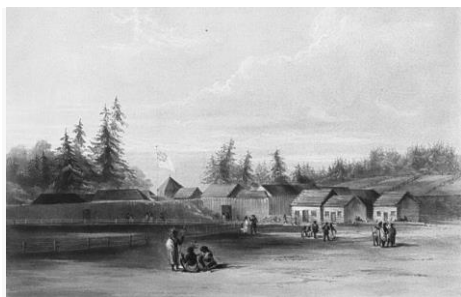

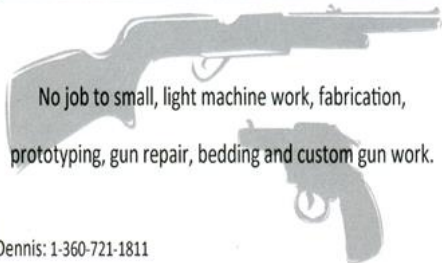
